**RENOUNCE OF RECLAMATION OF RESPONSABILITY STATEMENT**

**1. Voluntary participation:**

Declare:

To accept riding voluntarily in an engineered vehicle or motorcycle at the **Oman 4x4 Track/Race Event**, expressing my full capacity to grant such a consent.

**2. Risk assumption:**

I am aware that when **riding** at the **Oman 4x4 Track** I will take part in a **dangerous activity**. I am taking part in these activities in a voluntary way and with full awareness of the **danger involved, and I accept all the risks that these activities imply, and I confirm this statement by signing this document.**

**3. Release:**

I declare that, from the first time I am using the track to ride at the **Oman 4x4 Track/Race Event** I do it at my own risk and responsibility, renouncing myself, my inheritors and other legal representatives, to the exercise of any claim for injury or damage or other penal or civil action of contractual or extra-contractual responsibility that we may have now or once the activities will be finished, against **Oman Automobile Association**, or against the people employed or rendering their services to these companies, derived of the use of the track or other facilities.

**4. Indemnification:**

The Driver/Team, whose personal particulars are at the bottom of this document, assumes his responsibility for the damages suffered during the testing and races that will take place at **Oman 4x4 Track**, being the Organization excluded of such a risk. The Driver/Team agrees not to take legal action against the owners of **Oman Automobile Association** or its employees for any injuries or damages suffered during the event.

**5. Learning and acceptance:**
